

**1. Approval of previous minutes for meeting held on 17<sup>th</sup> March 2024**

## **2. Election of Office Bearers**

## **National Board nomination**

**Tony Price was nominated to remain as the ANPRA representative for Victoria**

**Tony Price advised that the ANPRA are now members of the Federation Colombophile Internationale (FCI). There will be many benefits in being a member. As an example, Australian Racing Pigeon organisations will be able to obtain a 50% reduction for rings and they will also have a greater opportunity to improve their marketing of the sport.**

**The ANRPA are still looking for a Victorian country representative to join. They have monthly conference calls via video link.**

### **3. Inwards/Outwards correspondence**


**Andrew Demidowski advised that Dr Colin Walker OAM submitted an email to the VRPB for consideration. This was reviewed under General Business.**

### **4. Review of Action Plan 2024**

**Andrew Demidowski advised that all items on the action plan were completed. He advised that he had completed the Transportation and Liberation Guidelines together with the accompanying checklist**

### **5. Treasurers Report**

**Marc Tenaglia advised that no money was raised in 2024 but there were expenses for the successful VCAT Case which cost just over \$10,000. He advised that as a result of the Varelas case the Western Fed. has had much less problems with the Local Councils in his area. As an example, Brimbank Council has now started to reissue their permits, and both Hobsons Bay and Melton Council are now dealing with permits with less hesitation. The VRPB approved the fat eye trial which was published by Dr Colin Walker and the VRPB still has around \$1000 left in the Disease Management Fund for any further trials. Marc explained to the attending members the origins of the money obtained by the VRPB and how it was initially going to be distributed evenly to each of the Metropolitan racing pigeon organisations as well as for Prostate Cancer Research but due to the impending Varelas vs Brimbank Case it was decided by the Victorian National Conference Committee that the**



money will be held by the VRPB in total for the impending VCAT cases and a smaller donation will be made for Prostate Cancer Research. Marc advised that a just over \$6000 will be donated for Prostate Cancer research

It was voted unanimously to accept the Treasurers Report and Tony Price thanked Marc for the excellent work he was performing as Treasurer


## **6. Review of VRPB Transportation & Liberation Guidelines & VRPB Liberation Risk Analysis Checklist**

Andrew Demidowski advised that he has completed his work with these guidelines and outlined the problems he had trying to put this document together. He advised that the guidelines were developed using international standards obtained from Colin Walker together with the guidelines used by South Australia and Central Cumberland, Marc Tenaglia advised that these guidelines will now be improved by himself and several other volunteers from other states.

## **7. Review of VCAT Planning Decision – Darebin vs Terry Varelas & VRPB**

Charles Hider advised that as a result of the Varelas Case pigeon racing will no longer be defined within the definition of 'animal husbandry' and will now be dealt with by Councils as a general planning application (amenity issues). Basically, it has changed dynamics of Council planning applications.

Charles also advised that Ergun Avci VHA has now rebuilt his loft and made an application to Manningham Council for a Town Planning permit. He is now waiting to see if his application will be successful.



## **8. Development of Standard Council Permit Conditions**

Andrew Demidowski asked the members whether the permit conditions developed by himself and Charles Hider could be placed on its website for Councils to use when considering an application. Charles Hider advised this could be done without any problems.

## **9. Review of Contact list for Victoria 2024 to be approved**

Andrew Demidowski advised that a contact list has been developed by the VRPB of all known racing pigeon organisations in Victoria which included the names, emails and phone number of the Presidents and Secretaries for these organisations. He wanted to know whether these could be made available for everyone on the VRPB Website? He was advised to do this he would need to get the individual permission from each organisation for privacy issues.

This will be done in due course and a contact list with only those organisations that give the VRPB permission will be made available on its website.

## **10. Social Media Policy**

Tony Price advised that all racing pigeon organisations need a social media policy.

This will be developed using the South Australian Homing Pigeon Association as a model policy

## **11. Review of VRPB Code of Practice – any suggested amendments**



**Marc Tenaglia advised that a rule change was required. Rule 4.9.3 will be changed to - 1 hr. before liberation to until liberated**

**No new ideas were raised so Andrew will liaise with the VRPB members in due course to develop some new action items for 2025.**

## **13. General Business**



**Tony Price read out the email submitted by Dr Colin Walker OAM sent the VRPB with his ideas about what activities the VRPB could undertake in the future. Each item was discussed at length to determine if further action is warranted.**

**From this email it was decided that Andrew will follow up with Dr Colin Walker OAM what is involved in obtaining a PIC and what benefits it has for pigeon flyers. Tony Price advised that he made a submission on behalf of Dr Colin Walker OAM regarding his request to undertake a study on how to best deal with diseases in One Loft Races currently held throughout Australia to the National Committee but this was “knocked back”.**
